- The Touch for Health School faculty appointed to my country is the IKC's representative and administrator of Touch for Health School policy.
- The International Kinesiology College is the parent body for Touch for Health School training.

Furthermore

- I agree to promote the Touch for Health self-responsibility model when teaching Touch for Health School classes
- I agree to abide by the Code of Ethics of the Touch for Health School
- I understand that Touch for Health does not claim to cure, treat and diagnose diseases and I will not imply that using Touch for Health techniques will do so
- I agree to use only original manuals, certificates and other resources endorsed by the IKC when teaching Touch for Health School classes
- I agree to use only the official syllabus material / information supplied by the IKC when teaching Touch for Health School classes
- I agree to update my Touch for Health School instructor registration by maintaining the continuing education requirements of the Touch for Health School of the IKC
- I will maintain appropriate insurance policies for risks concerning professional negligence, public liability and any other risk required by IKC
- I understand the IKC will at my request from time to time, give me, at no charge, a copy of the latest syllabus and version of this document if they are not available to me on the IKC's website
- When teaching Touch for Health School classes, I agree to issue TFH School certificates obtained through the faculty of my country.
- I understand that I do not have nor will at any time claim any intellectual property rights in the IKC and TFH logos, and the written and electronic syllabus materials, certificates and teaching manuals.

- I understand that while I am a current registered TFH Instructor, I may use the IKC logo to advertise my status on my business resources. I agree not to make claims on these resources that are contrary to IKC / TFH School policy and Codes of Ethics. In the event that my registered instructor status lapses, I agree to remove immediately the IKC logo from my business resources and any other places I display the IKC logo.

If any part of this document is determined by a Queensland, Australia, court or tribunal to be unenforceable, that part can be removed from this document without affecting the remainder of it. If, by removing that part, IKC’s rights and powers are diminished, my license to teach the syllabus is automatically terminated without any penalty to IKC.
